ARTICLES OF INCORPORATION

ARTICLE I

The name of the corporation is: CALIFORNIA STATE GRANGE FOUNDATION.

ARTICLE II

- A. This corporation is a nonprofit Public Benefit Corporation and is not organized for the private gain of any person. It is organized under the Nonprofit Public Benefit Corporation Law for charitable purposes.
- B. The specific purposes of this corporation are to serve as the charitable arm of the California State Grange, a chartered division of the National Grange of the Order of Patrons of Husbandry, and to support the California State Grange's work, programs, and goals relating to: educational activities to the public concerning, but not limited to, the preservation of the agricultural heritage and traditions of California and the United States of America through publications, workshops, or otherwise; assistance in research as necessary to further these activities; educational assistance in the form of scholarships; provision for the public safety and general welfare of the populace of our state and nation; and contributions to other organizations that serve such purposes

ARTICLE IV

- A. This corporation is organized exclusively for charitable and educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code.

No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate or intervene in any political campaign (including the publishing or distribution of statements) on behalf of any candidate for public office.


ARTICLE VII
